News from UNIAPAC Executive Office

UNIAPAC International Board in Madrid on April 26th. It was attended by 50 participants representing 20 National Associations. This participation was a great sign of support. A special thanks to MAPFRE and ASE who hosted the Board under the efficient leadership of Carlos Alvarez. An address by Professor de Woot at the dinner on the eve of the Board was particularly enriching and led to a very rich discussion at the Board on our prophetic role in the society. Besides the update on the UNIAPAC actions the Board focused on a deepening of our CSR initiative under the leadership of our Latin American friends

UNIAPAC Foundation. We have been able to finalize the recruitment of the General Manager in the person of Eduardo ANINAT. Eduardo is a Chilean citizen, Doctor in Law from Harvard University, started his career as a high level strategy consultant in Chile, was Finance Minister of Chile, then Deputy General Manager of the IMF with Michel Camdessus and Ambassador of Chile to Mexico. 61 years old, he was member of Board of Directors of various international companies. Very enthusiastic about our Foundation project he will join full time as of September 15th. I am convinced his dynamism, experience and high level network will bring a lot to the Foundation. He will be present at the International Board in Sao Paulo on September.

We also finalized during this quarter the administrative support for the Foundation, with its first Board in Madrid on April 25th, the nomination of Mazard firm as the Auditor, and the choice of an Accounting firm. The goal is really to call upon a very professional support to warrant a full proof and transparent operation.

UNIAPAC Africa: On May 29th, Pierre Lecocq and Jean-Baptiste Homsy, the UNIAPAC Africa President attended the special gathering organised in Kinshasa, RDC, to celebrate Father EKWA retirement after 26 years as General Manager of our UNIAPAC Association in RDC, CADICEC. a) Political context:

* **April 25th 2010 :** Legislative elections massively won by the party of center right Fidesz whose President is Viktor ORBÁN.

The Parliament voted a law declaring June 4th, day of the signature of the Trianon Traité in 1920, as the day of the national Union, which shows that the Hungarian are all part of the Hungarian United nation. That is the first time in Hungary that a law begins by:

"invocatio Dei" : "We, members of the Hungarian Parliament, those who believe that God is the Lord of the History...".

It shows that spirituality will have a great importance in the action of the new Government.

***June 16th 2010:** Monthly meeting of the association: Participation of the French ambassador in Hungary René ROUDAUT who talked about:

- the ethical behavior of the business leaders in Hungarian.
- the importance of the solidarity, sharing, tolerance towards other religions, dialogue, our duty to work for a more human world
- Christian values which are at the same time European fundamental values
- the current crisis, moral and spiritual, the problem of the Hungarian minorities

***ZKPS/SLOVENIA**

a) Conferences & Events

***May 2010:** ZKPS members participated to the round table organized by the Catholic weekly magazine Druzina (Family) and the Newspaper Tretji dan (The 3rd day) entitled: "From the ethical to the economic crisis". It is a common agreement to recognize that the ethical crisis has preceded the financial and the economic one. Solutions for the economic crisis should be searched in the society as well as in the political, financial and business world.

*** June 2010:** ZKPS is about to publish an article in a monthly magazine entitled "Role of Christian businessmen in the crisis" for the charity organization "Karitas". The negative public opinion on the role of entrepreneurs in the society is discussed. Christian businessmen are also concerned. There is a need to change the opinion. In this article, UNIAPAC and the Slovenian association will be presented as well as the UNIAPAC book "The profit of values".

* ZKPS does not keep participating to the political debate on the rights of homosexual couples in their society. The Slovenian government has been preparing a new law on family, which redefines a family as a "relation of two persons" not of "a man and a woman". It has been discovered that the Ministry of social affairs has not worked systematically on the law preparation and that the controversial redefinition of marriage and the adoption of children by homosexual were introduced without any previous studies.

The closing of the meeting was headed by the father Quiroga who represented CELAM, Sr. Pascual Rubiani, representing Uniapac LA and Sra. Vivian Ossio representing Cochabamba.

***June 16th 2010:** Second CCDAL of the year in Cochabamba, during the days of the X Simposio/ 20 participants of 7 Latin American countries. Different subjects related to the future activities of Uniapac/ Approval of the Acts of the last CCDAL in Madrid last April 26th 2010.

Raised subjects: ***Foundation Uniapac/** José Ma. Simone, the 2^o vice president of Uniapac LA talked about the Uniapac Foundation, and informed us that Sr. Eduardo Aninat, past minister of Treasury Department in Chile and Deputy General Manager of the IMF will be the next General Secretary in September; he will leave in Paris. The working plan of the Foundation for the next 3 years will be sent to the presidents of the associations. ***CSR advances:** Juan Manuel López Valdivia opened the debate through our book "The Profit of Values", the Protocol and what we have to do now, taking into account the Pope Encyclical Caritas in Veritate. ***Responsible Entrepreneurship:** Father Llorente talked about our part as christian, and referring to Prof. de Woot intervention, said that "we are not christian business leaders, but we are christian who respond to our call of entrepreneurship".
